- **Research Topic**: *Kinetic Limits of Many-Body Systems*. Development of techniques for studying the dynamical laws of systems of interacting particles with random initial data, which form the basis of the kinetic theory of gases. In particular, the goal is to derive and describe, using rigorous mathematical methods, the solutions to the Boltzmann Vlasov -

Landau equations in appropriate scaling limits that model systems with a large number of components in regimes of low density or weak coupling, and in the context of realistic and physically relevant interaction models.

- **Contract Type**: Researcher (Type A) on a full-time fixed-term basis, duration of 3 years.
- **Salary**: Equivalent to 100% of the starting salary of a full-time Researcher (gross yearly salary is approximately 39k euros).
- **Teaching Load**: Between 36 and 72 hours of lectures per academic year.
- **Eligibility Requirements**:
- A PhD in Mathematics or Physics (or equivalent foreign degree);
- Applicants must not have exceeded 12 years of prior contracts and research grants as described by Law 240/2010;
- Ineligibility applies to candidates with familial ties (up to fourth degree) to faculty of the Department, Rector, General Director, or members of Boards.
- **Selection Procedure**:
- Evaluation of qualifications and scientific output (up to 12 selected publications);
- Knowledge of English will be assessed;
- A public seminar and interview will be held for shortlisted candidates.
- **Application Deadline**: 30 days from the publication of the notice in the Official Gazette (Gazzetta Ufficiale IV Serie speciale Concorsi ed Esami).

Art. 2 – Selection Criteria

The preliminary evaluation of the candidates, including a reasoned analytical assessment of qualifications, curriculum, and scientific production (including the doctoral thesis), shall be carried out on the basis of the following criteria and parameters, consistent with those commonly used in the international scientific community:

Number of publications eligible for merit evaluation: no more than 12.

Foreign language subject to verification of the candidate's scientific language skills: English.

Preferred qualifications: none.

Required scientific and/or technological experience, in relation to the research line on which the researcher will be engaged:

- √ PhD in Mathematics or in Physics;
- ✓ University-level teaching experience in Italy or abroad;
- ✓ At least 1 year of postdoctoral experience on projects related to mathematical physics;
- \checkmark Previous experience in the use of analytical techniques typical of statistical mechanics and kinetic limits;
- ✓ Knowledge of analytical and probabilistic techniques in non-equilibrium statistical mechanics;
- ✓ Knowledge of techniques for the study of scaling limits of many-body systems and collisional kinetic theory.

Database with respect to which the candidate must self-certify bibliometric indicators relating to their scientific output: Scopus and MathSciNet.

Article 3 of the call – Application for Admission

The application to participate in the selection procedure, written on plain paper following the attached template (Annex A), addressed to the Director of the Department of Mathematics Guido Castelnuovo of Sapienza University of Rome, must be submitted

electronically (in PDF format with scanned signature and all attached documents) to the email address matematica@cert.uniroma1.it within thirty days from the day following the publication of the notice of this call in the Official Gazette IV Special Series - Competitions and Exams. If the deadline falls on a public holiday, the deadline is extended to the next working day.

In the application, candidates must indicate a personal email address to which all communications will be sent, including the invitation to the interview, with no further obligation of notice. The candidate must submit electronically a curriculum vitae in the standard European format, with a list of publications attached, and must also indicate in the application the publications selected as most significant.

If electronic submission of the application is not possible, it may be sent by registered mail with return receipt to the following address: Department of Mathematics Guido Castelnuovo of Sapienza University of Rome – Piazzale Aldo Moro no. 5 – ZIP Code 00185 - Rome (RM) – within the term of thirty days starting from the day following the publication in the Official Gazette of the notice of this selection. The postmark of the post office will be used as proof. If the deadline falls on a public holiday, the deadline will be extended to the next working day.

The selected publications must be sent in PDF format, or by registered mail with return receipt to the Department of Mathematics Guido Castelnuovo of Sapienza University of Rome – Piazzale Aldo Moro no. 5 – ZIP Code 00185 - Rome (RM) within the deadline of the call. The candidate may submit any title deemed useful for evaluation purposes, including letters of reference, even in a foreign language, written by Italian or foreign scholars. Letters of reference will be considered for evaluation only if attached to the application in encrypted PDF format. It is the responsibility of the scholar writing the letter to send the password to decrypt the file to the following email address:

concorsi.matematica@uniroma1.it; in the subject of the email, the number of the call and the candidate's name must be specified. The letters of reference must be attached to the application for the selection procedure.

In the application, the candidate must, under penalty of exclusion from the selection, declare:

- 1. surname and name;
- 2. date and place of birth;
- 3. residence;
- 4. tax code (only for Italian citizens);
- 5. nationality held;
- 6. registration in electoral rolls, specifying the Municipality and indicating, if applicable, the reasons for non-registration or cancellation; candidates who are citizens of foreign States must declare that they enjoy civil and political rights in their States of origin or provenance, or indicate the reasons for not enjoying such rights;

- 7. criminal record status, indicating any convictions and pending criminal proceedings;
- 8. current status with respect to military obligations (only for Italian citizens);
- 9. not having been dismissed or discharged from employment in a Public Administration for persistent poor performance and not having been declared disqualified from a state job under Article 127, paragraph 1, letter d), of Presidential Decree 10 January 1957, no. 3 (only for Italian citizens);
- 10. adequate knowledge of the Italian language (only for foreign citizens);
- 11. not having a family relationship or affinity up to the fourth degree inclusive, or a relationship of marriage with a professor belonging to the Department or structure making the call or with the Rector, the General Director or a member of the Board of Directors of the University of Rome "La Sapienza" (Article 18, paragraph 1, letters b) and c), Law 240/2010).

The following documents must be attached to the application, under penalty of exclusion:

- 1. copy of a valid identity document;
- 2. copy of the tax code (only for Italian citizens);
- 3. dated and signed curriculum of scientific-professional activity;
- 4. titles considered useful for the selection with related dated and signed list;
- 5. scientific publications already printed by the application deadline, with a numbered, dated, and signed list indicating the authors' names, title, publisher, date and place of publication or title, collection or volume number, and year of reference.

The titles the candidate intends to submit must be presented in the original or in a copy declared to be conforming to the original by self-certification pursuant to Articles 46 and 47 of Presidential Decree no. 445/2000 (Annexes B and C).

For Scientific Disciplinary Groups (GSD) where it is internationally common practice, in the application, under penalty of exclusion, the candidate must self-certify the bibliometric indicators related to scientific production taken from the database indicated in Article 2 of this call.

All methods of self-certification mentioned so far apply equally to Italian and EU citizens (Article 3 of Presidential Decree no. 445/2000).

Non-EU citizens residing in Italy, according to the provisions of the residents' registry regulations approved by Presidential Decree no. 223/1989, may use substitute declarations only to the extent that they concern states, facts, and personal qualities certifiable by Italian public or private bodies.

Certificates issued by the competent authorities of the State of which the foreigner is a citizen must comply with the provisions in force in that State and must also be legalized by the competent Italian consular authorities.

Documents written in a foreign language, if different from English, French, German, and

Spanish, must be accompanied by a certified translation into Italian, carried out by the competent diplomatic or consular representation or by an official translator.

For publications printed in Italy, compliance with the obligations established by Article 1 of the legislative decree of 31 August 1945, no. 660 or by Articles 6 and 7 of Presidential Decree of 3 May 2006, no. 252 (in force since 2 September 2006) must be met.

For publications printed abroad, the date and place of publication must be indicated.

Publications must be submitted in their original language and, if in a language other than Italian, French, English, German, or Spanish, must be accompanied by a translation into one of those languages. Translations must be submitted along with the original texts, in a typewritten copy certified as conforming to the original in accordance with current regulations.

Substitute declarations of affidavit allow the citizen to prove all statuses, personal qualities, and facts not expressly indicated in Article 46 of Presidential Decree 445/2000.

These declarations, governed by Article 47 of Presidential Decree no. 445 of December 28, 2000,

do not replace administrative certifications, but rather affidavits belonging to the category of recorded statements.

With the substitute declaration of affidavit, it is therefore possible to certify: facts, personal qualities, and statuses known directly by the interested party, which are not included among the self-certifiable data by means of a substitute declaration of certification.
